



COURTCALL VIDEO: DOCUMENT COLLABORATION (PARTICIPANT)

Document Collaboration is a browser based feature which opens in a new tab or window. It allows parties to work on documents while maintaining audio and video in their meeting.

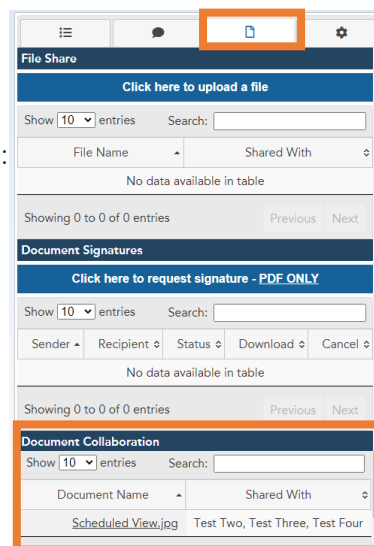
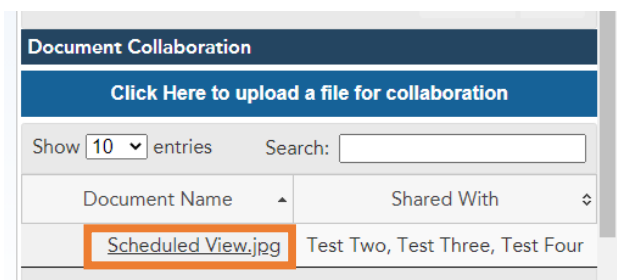
Options Within Document Collaboration Include:

- Draw
- Freeform Highlight
- Text Highlight
- Insert Images
- Exhibit and Other Stamps
- Notes
- Text Box

Only hosts are allowed to upload a document for collaboration. Non-host participants in a meeting are able to be added to the document with full collaboration permissions or read-only permissions. Non-host participants cannot initiate the document collaboration feature.

To participate in document collaboration, participants should:

1. Go to the file tab
2. Under Document Collaboration section you will see any document on which you have been invited to collaborate:
3. Select the file you wish to collaborate on from the list by clicking the file name:



4. The file will open in a new tab or window. If the host has given you collaboration capabilities, you will be able to use the toolbar of options. If you have read-only permissions, you will be able to see the document being worked on by others in real-time.
